

# **TRRAC 2026 RRP Thoroughbred Makeover Incentive Program**

## **Official Rules and Terms & Conditions**

### **1. Purpose and Award.**

The Thoroughbred Retirement, Rehabilitation & Careers ("TRRAC") Makeover Incentive Program ("Program") provides a one-thousand dollar (\$1,000.00) award to the highest-placed TRRAC-adopted Thoroughbred competing in the 2026 Retired Racehorse Project (RRP) Thoroughbred Makeover ("Makeover"). The Program is designed to encourage responsible training, competitive excellence, and long-term aftercare success.

### **2. Eligibility Requirements.**

- (a) The horse must have been adopted directly through TRRAC and remain in good standing under the TRRAC Adoption Agreement at the time of competition.
- (b) Horse and adopter must be identifiable through TRRAC adoption records, Jockey Club registration, and microchip verification.
- (c) The horse must be officially accepted and entered into the 2026 RRP Thoroughbred Makeover. Proof of entry is required.
- (d) TRRAC reserves the right to verify ownership, entry status, and compliance with adoption terms at any time.

### **3. Registration for the Program.**

- (a) Participants must submit a completed Incentive Registration Form no later than thirty (30) days prior to the commencement of the Makeover competition.
- (b) Participants must provide RRP acceptance documentation upon request.
- (c) Failure to register or provide necessary documentation may result in ineligibility.

### **4. Determination of Winner.**

- (a) The award shall be granted to the TRRAC-adopted horse achieving the highest final placement in any Makeover discipline as reflected in the official final results published by RRP.
- (b) TRRAC shall rely exclusively on RRP's official scoring and placement tables; no independent scoring or challenges will be considered.
- (c) In the event no TRRAC-adopted horse completes the Makeover, no award will be issued.

### **5. Tie Resolution.**

In the event two (2) or more eligible TRRAC-adopted horses achieve identical highest placements, the \$1,000.00 award shall be divided equally among all tied competitors. Each tied competitor shall receive an equal share of the total award.

## **6. Payment Terms.**

- (a) Award payment shall be issued within thirty (30) days after verification of results and participant eligibility.
- (b) Payment may be issued to the adopter or to the competing trainer only with written authorization from the adopter.
- (c) Payments may be issued by check or electronic transfer at TRRAC's discretion.

## **7. Compliance and Conduct Requirements.**

- (a) All participants must comply with TRRAC policies, the TRRAC Adoption Agreement, and RRP rules and regulations.
- (b) TRRAC reserves the right to disqualify any participant engaging in misconduct, neglect, fraud, misrepresentation, or activities deemed detrimental to the welfare of the horse or reputation of TRRAC.
- (c) Any welfare-related disqualification by RRP shall result in automatic disqualification from the Program.

## **8. Horse Welfare Requirements.**

- (a) The competing horse must appear at the Makeover in humane, healthy, and appropriate athletic condition.
- (b) TRRAC may request veterinary statements, photographs, or welfare documentation at any time.
- (c) TRRAC may revoke eligibility if welfare concerns arise.

## **9. Changes in Ownership or Status.**

- (a) Any transfer of ownership after adoption must be reported to TRRAC prior to the Makeover.
- (b) Failure to update ownership information may result in disqualification.
- (c) Horses sold, transferred, or placed without TRRAC approval under the Adoption Agreement may be deemed ineligible.

## **10. Media, Publicity, and Release.**

- (a) Participants grant TRRAC a non-exclusive, royalty-free license to use photographs, videos, updates, and competition results for promotional, educational, and fundraising purposes.
- (b) Winner(s) agree to provide at minimum one (1) photograph and a brief written update for publication.

## **11. Program Modification or Cancellation.**

TRRAC reserves the sole right to modify, suspend, or terminate the Program or its rules at any time due to unforeseen circumstances, funding changes, welfare concerns, or administrative necessity. Changes shall not be applied retroactively to disadvantage already-eligible participants except under welfare or compliance grounds.

## **12. Final Authority.**

All decisions made by TRRAC regarding eligibility, scoring interpretation, award distribution, and Program administration shall be final, binding, and not subject to appeal.
